Classes Offered

Classes are aligned with Work-bound, College-bound and Life Skills Academies based on students' goals. A comprehensive assessment process ensures that students select the appropriate Academy

English & Spanish GED®/High School Equivalency (HSE)

We offer classes during the day, and evening. The HSE exam is a more rigorous test and is designed to be more relevant to a job market that demands workers have technological skills and training. The new exam will also focus on college and career readiness skills in math, reading & writing, science and social studies. Obtaining your High School Equivalency will enable our students to acquire or retain better paying jobs, and continuing in higher education, thereby helping their families achieve and sustain economic prosperity.

English as a Second Language (ESL)

Our adult education program provides ESL classes for individuals wishing to improve their reading, writing, speaking, and listening abilities in English in a contextualized setting that promotes college and career readiness.

English for Professionals

This class provides professionals with foreign degrees with ESL instruction contextualized for college and career readiness.

English Literacy/Civics

Our English Literacy/Civics Education provides students with preparation classes for those interested in obtaining their citizenship. The instruction and materials are in English. In order to register for this class, a student must take a test to verify that their English skills are at the level necessary to be successful.

Transition to Higher Education Class

This course provides instruction to develop skills in language structure and in basic math to intermediate algebra. Students must co-enroll in the College and Career Readiness class for a successful transition into postsecondary education or training. Students must have a stated goal to enroll into postsecondary education or training.

Family Literacy Academy

The Family Literacy Academy is a comprehensive family-centered education program that involves parents and children in a cooperative effort, helping

parents to become partners in their children's education. It involves the following four components:

Adult Education: Offers ESL instruction.

Early Childhood Education: Provides educational services for children between the ages of 2-4. Program activities are age appropriate and respond to the growth and development process of individual children. The goal is to encourage emergent literacy of children and ease the transition of young children into school.

Parenting Education: Enhances the parent's skills on child rearing practices and focuses on the central role parents play in the development of their children. Parenting sessions also include information on community resources and how to access services to address personal and family needs.

Interactive Literacy Activities (ILA): These are intergenerational activities that allow the child and parent an opportunity to work together to enhance literacy development. Who qualifies for these services? The parent must also have the need to learn English. Currently, the program is housed at two elementary schools: Benito Martinez and Robert R. Rojas.

HSE and ESL Distance Learning

All of our adult education students **must use** distance learning to accelerate or intensify face-to-face instruction. Students will enroll in a distance education class while they are taking a regular class which we call "blended classes." USA Learns or Burlington English for ESL students and Edmentum Plato for advanced ESL and/or transition classes are the **only** DL programs approved for Community Education students. A total of at least 8 hours per month and 4 for vocational students are mandatory.

Integrated Education and Training (IET)

As part of the Far West Adult Education Consortium Academy Model, Community Education offers industry recognized certifications including Microsoft® Office Specialist, Computer Maintenance and Repair, and Dental Assisting. This vocational training is integrated with basic academic skills class including workforce preparation activities.

English language learners are offered vocational training in combination with contextualized ESL, civics and workforce preparation instruction.

Registration Procedures Interested students must participate in all information and registration session and complete a two day orientation and testing prior to attending the first day of class.

1. Comprehensive Assessment Interview

Students must present an official form of identification that includes a birth date and their Social Security card, if available.
card and provide information needed for the registration card.

2. Testing

Students are tested accordingly in order to be placed in a class that best meets their needs.

3. Attend a mandatory Orientation. Students who do not complete the orientation will not be allowed to start classes until the next intake period.

Drop/Planned Gap Procedures

If student is to be dropped from the class due to attendance issues or other reasons, the program personnel and the student must complete an Add/Drop form and turn it into campus personnel in room 307.

If the student initiates the drop student must inform the instructor/testing personnel in room 307 so that they may initiate your withdrawal. If possible, student should provide at least two weeks advance notice if they want to drop. In the event of an emergency in which advance notice is not possible, please inform your teacher and campus personnel in room 307. So that they can complete the Add/Drop form and can schedule the final post-test.

If the student is planning to return to the program after leaving for more than 90 days but less than 180 days, he or she should fill a planned gap form.

Learning Styles and Strategies

Adult learners bring experiences and self-awareness to learning that make them different than young learners. Your teachers are trained to use differentiated instructional strategies such as lectures, role playing, simulation, group discussions and video presentations that address the primary learning styles:

- Visual learners tend to learn by looking, seeing, viewing, and watching.
- Auditory learners tend to learn by listening, hearing, and speaking.
- Kinesthetic learners tend to learn by experiencing, moving, and doing

Student's Rights & Responsibilities

Community Education receives its directives from the Texas Workforce Commission. Therefore, Adult Education students are governed by the same Student Rights and Responsibilities as any adult student across the state.

Student Rights

You have the right to an education that will enable you to accomplish your goals. You have the right to be treated with respect in the classroom and in regard to your personal and educational information. Personal and educational information will be kept confidential and only be released with your written permission.

Equal Opportunity is the Law

It is against the law for SISD Community Education to discriminate on the following bases: against any individual in the United States, on the basis of race, color, religion, sex, national origin, age, disability, political affiliation or belief.

Student Responsibilities

Learning

You share responsibility with the teachers for your own learning. You should spend some time when you are not being taught directly by the teacher studying on your own. There are excellent computer programs, videos, websites and books at your disposal (which we will be happy to help you access).

Participation

You are responsible for helping others to learn by being respectful. During class, you should ask questions if you don't understand. You should participate in all activities. You should help others to understand. You should not be having casual conversations during the class. Your talking may disturb others who are trying to hear what the teacher is saying, and you will not be listening to the lesson.

Code of Conduct

Equipment Use

You are responsible for taking care of any equipment, materials, and yourself in the classroom. Please do not eat or drink at the computers. If you have a problem with a computer, tell a teacher. If you spill something or make a mess, clean it up. Please do not write on the dictionaries or other materials.

If you damage, destroy, lose, sell, or otherwise dispose of department property entrusted to you, you will be charged the full extent of the damage or loss and will be subject to prosecution under State laws and disciplinary action by the department.

Health & Hygiene

In the event you are ill, we encourage you to stay home in order to avoid spreading a communicable disease. Proper hygiene, such as frequent handwashing can prevent the spread of germs.

Loitering

Students attending adult education should leave campus when studies are completed for the day. Loitering is not allowed on premises. Suspension of student from campus or site will occur if this rule is not followed.

Other Prohibited Activities

Engaging in such acts as stealing, disrupting classes or disturbing normal operations, gambling, profanity, verbal or physical abuse, and possession of firearms and other dangerous weapons will make you liable to disciplinary action, probation, or expulsion.

Plagiarizing, cheating, and violation of copyright laws are serious offenses. Proper credit must be given to the original writer or creator of copyrighted materials.

There is to be no use of tobacco in any form on school premises including parking lot or car, in the classroom areas, halls, or restrooms. No cigarettes or electronic cigarettes allowed. Under no conditions will alcoholic beverages or illegal drugs, or persons under the influence of drugs or alcohol, be permitted on the premises or allowed to participate in any program activity.

Involvement in the unlawful possession, use, or distribution of these result in immediate suspension.

Administration will cooperate with law enforcement officials in the apprehension of students engaged in these activities. You will be subject to all national, state, and local laws and ordinances.

Dress Code

Students shall be dressed and groomed in a manner that is clean and neat. The SISD Community Learning Center prohibits any clothing or grooming that may reasonably be expected to cause disruption of or interference with normal school operations.

Furthermore, the following are specifically prohibited:

- Clothing with pictures, emblems, or writings that are lewd, offensive, vulgar, or obscene.
- Halter-tops, bare midriff, low cut and see-through apparel

If the teacher or director determines that a student's clothing violates the dress code, the student will be given an opportunity to correct the problem. If not corrected, the student may be asked to go home and change, and if the problem is still not corrected student may be dropped from the program.

Cell Phone Use

SISD Community Education recognizes the usefulness of cellular telephones and other devices as a means of supplementing educational instruction. Cell phones and electronic devices may only be used at teacher discretion. This also includes the use of headphones. If you must use your cell phone for personal calls, please step out of the classroom and keep your call to a minimum. Absolutely no cell phones during testing.

Class Readiness

The following class materials should be purchased by the student and be brought *daily*:

- Pen and pencils
- Loose-leaf paper
- 2-inch binder, with divided section, calendars, etc. as required for each instructor
- Composition notebook
- Head phones if required

Scheduling of Breaks

* For classes scheduled for more than 3 hours, a 15-minute break is permitted at the discretion of the instructor. For example, for morning classes at the SISD Community Learning Center, this break will be 10:00 a.m.–10:15 am.

* For classes scheduled for 3 hours or fewer, early dismissal of 15 minutes is permitted in lieu of a break. It is encouraged that personal needs such as eating and going to the bathroom be taken on scheduled breaks. **Remember, smoking or the consumption of liquor or any illegal substance is strictly prohibited on school property.**

Parties & Celebrations

SISD Community Education **allows celebrations at the discretion of the instructor.** An end of course a celebration may be scheduled the last hour of class.

Emergency Procedures

To call 911 from a SISD classroom phone, dial 9-911. Please stay on the line while they ask you for information on where to send emergency personnel. Emergency procedures specific to your classroom site should be visibly posted. Please be aware of the procedures.

In the event of a weather emergency, SISD will use available information to determine if classes will be cancelled, have a delayed start, or, if classes are in session, be dismissed early. In some instances, adverse weather conditions may be sufficient cause to hold students at school. Students may obtain information from the school district's website and through local radio or television stations. Student absences during inclement weather will be excused.

Attendance Policy

Every student must attend at least 90% of class instruction.

*If attendance drops below 90%, the teacher will contact the student and notify the program director. If attendance problems persist, the student may be dropped from the program and **may not** be eligible to re-enroll.*

Every student must complete two (2) hours of Distance Learning each week during their own time. Students may use computers on campus to complete this requirement.

Every student must attend class as scheduled; this means being on-time and not leaving early.

Students must attend class as scheduled. SISD Community Education considers 3 tardies/early leave as equal to 1 absence. ("Tardy" means 15 minutes late, and "Early Leave" means leaving before class is dismissed.)

Every student must sign-in every day and record the entry and exit time every day with actual time. The sign out time must be documented at the end of the class.

Students must accurately sign-in and sign-out of class every day with the accurate time.

Every student must submit an absence form to instructor explaining the reason for his/her absence.

Individual Training, Education and Career Plans (ITEC)

Every student is responsible for assuming an active role in the planning, assessment, and reflection required when developing current and future academic, career, and technology goals. Students review their ITEC by reflecting on past goals, revising and/or setting goals, and developing plans to meet these goals. This level of student participation fosters a strong learning environment.

Grievances & Complaints

AEL program participants can start a complaint or grievance with their teacher to resolve any problems. If that is not possible or the issue is not resolved, the participant may file a written complaint to:

The complaint should include the issue or problem and the name and contact information of the person filing the complaint. The complaint will be reviewed and the participant will be notified in writing of any decision made with respect to the complaint.

Discrimination Complaints

If you think you have been subjected to discrimination under an Adult Education and Literacy financially assisted program or activity, you may file a complaint within 180 days from the date of the alleged violation with either the Equal Opportunity Officer for the Socorro Independent School District, 12440 Rojas Drive El Paso, TX 79928 or the US Department of Education. If you file your complaint with the Socorro Independent School District, you must wait either until a written Notice of Final Action is issued or until 90 days have passed (whichever is sooner) before filing with the US Department of Education, 400 Maryland Ave SW, LBJ Room 2E-349, Washington, DC 20202-4537
