1. AVID Center Agreement - Summer Institute  
INFO: \*\*This ongoing agreement provides a program to increase district wide learning and performance to ensure that all students will become educated, responsible participants and leaders in our society and for professional materials, training, and membership fees for 70 Socorro district employees and curriculum libraries for 11 campuses. 1. Department of Defense Education Activity Grant

INFO: \*\*New funding opportunity for military-connected LEAs with a minimum 25% military-connected (in at least half of schools proposed). Supports research-based programs to increase student achievement and ease the challenges that military children face due to their parents' military service.

INFO: \*\*Districts and open-enrollment charter schools are required to certify annually to the State Board of Education and the commissioner that for each subject in the required curriculum students have access to the instructional materials that cover all of the Texas Essential Knowledge and Skills.

I. Consider approval of TEA Low Attendance Waiver

INFO: \*\*The Texas Education Agency allows school districts that have experienced a significant drop in attendance to apply for a waiver application for low attendance days. This will allow the district to request that campuses that have attendance at least ten (10) percentage points below the last school year's average attendance due to safety issues be excluded from ADA calculations for the current year. Due to the safety-related issue that occurred at El Dorado High School on January 9, 2014; the District qualifies for this waiver.
