     \$210,183.88; the annual maintenance cost for Tyler Munis Support System and
     Operating System Database is \$256,240.17. (Maximum \$466,424.05)
  - 3. Memorandums of Understanding (MOUs)
    - a. Amarillo College to put in place the agreement to participate in the 2020 Texas Peer Mentor (TX-PMN) adult education publication; participation consists of writing assigned article/s for agreed-upon best practice/s for the Community Education Services Department. SISD's Department of Public Relations will act as the Author for article/s submitted. Each article accepted by the TX-PMN shall be paid in the amount of \$175 regardless of whether the article is published or not.
    - b. Texas Tech University for Principal Residency Grant Program to outline the Scope of Work with TTU as SISD has been awarded the 2020-2021 Prime Award-Principal Residency Grant. This award involves an approved collaborative effort between Socorro ISD and TTU. TTU has agreed to use its personnel, facilities, and reasonable effort in the performance of the work. (Maximum \$54,900-General and Federal Funds)
  - 4. Region 19 CO-OP Contract #15-7144, Frontline Education (ESPED) INFO: \*\*To continue services using the CO-OP contract #15-7144 Web-based program for Federal, State and Local compliance for students with disabilities, Americans with Disabilities Act and 504 Students and Students at Risk. (Maximum \$124,527.76-General and Federal Funds)
  - 5. Purchasing Cooperative(s)
    - a. ESC Region 19 Allied State Bid #19-7352, Segovia's Distributing Inc. for the acquisition of produce for school cafeterias for the 2020-2021 school year issuing purchase orders quarterly. (Maximum \$1,000,000-CNS Federal Funds)

The Socorro Independent School District officially closed Monday, March 16, 2020. The instructional period of closure for the 2019-2020 school year is from Tuesday, March 24 through Thursday, May 28, 2020.
- G. Consider approval of TEA Missed School Day Waiver/Instructional Continuity Attestation While Closed INFO: \*\*The Texas Education Agency allows school districts that have closed due to Covid-19 and continue to provide instruction at home to apply for this waiver as per Texas Education Code, §25.081. The Socorro Independent School District's emergency closure began Monday, March 16, 2020. The instructional period in which instruction transitioned to remote learning for the 2019-2020 school year is from Tuesday, March 24, 2020 through Thursday, May 28, 2020. The Socorro Independent School District attests that parents/guardians are being provided with the educational resources and implementation assistance necessary to support the remote learning instructional
