DEMERIT/GRADING SYSTEM

Demerits are verified by the Dance director. Captains maintain log.

- In a 9-week grading period, a dancer with 5 demerits, due to infractions or ineligibility, will be suspended from game/event participation for two weeks. After 5 additional demerits, the dancer will sit out the remainder of the 9 weeks. Each 9 weeks, the dancer will start with 0 demerits, if 10 demerits are reached in 2 nine-week periods during the year, the dancer WILL NOT be allowed to tryout the following year.
- Removal or quitting the team for Juniors, Sophomores and Freshmen wishing to try out for the following year, will require them to appear before a review committee comprised a school administrator and campus cheer sponsors.

A dancer may be immediately dismissed from the team for the following, but not limited to, reasons: Any illegal activity on or off campus (EX: drinking, smoking, illegal drugs), excessive and irreconcilable disruptive behaviors with themselves, teachers, coaches, administration, fans, squad members, conduct likely to bring the program's reputation into disrepute (EX: assault, verbal assault, inappropriate social media online posting(s) Facebook, Twitter, Instagram, TikTok or cellular text), and as otherwise deemed necessary by director, administration or athletic director.

SISD Anti-Bullying Agreement

Students shall not assault/bully/taunt anyone on school property or at any school related event. *An assault/bully/taunt is defined as intentionally, knowingly, or recklessly causing bodily injury to another person: intentionally or knowingly threatening another with imminent bodily injury; and or knowingly causing physical contact with another when the student knows or should reasonably believe that the other will regard the contact as offensive, provocative, or potentially dangerous.*

Bullying outlined:

- Criticism, /ridicule name calling and put downs
- Threats
- Picking/Teasing
- Humiliating
- Verbal and written warnings threats of intimidation (including social media)
- Spreading of rumors
- Physical intimidation of any kind
- Physical violence and attacks/pushing, pulling or hitting
- Theft-stealing of money or other property
- Exclusion from group or club (may be based on ethnicity, religion, gender etc)

Any severe behavior problem will result in a student/principal conference and removal pending satisfactory parent conference and may result in placement in the Alternative Education Program.

ANTI HAZING POLICY

Hazing is any action or activity that, regardless of location, intent, or consent of participants, causes or intends to cause: 1) physical harm, 2) mental harm, 3) anxieties, or 4) degrading or disgracing a person for the purpose of pledging, being initiated into, affiliating with, holding office in, or maintaining membership in an organization.

Hazing is an illegal activity (Texas Education Code 37.151-37.157) and is also a violation of the Socorro ISD Student Code of Conduct. Therefore, hazing under any circumstances will not be tolerated in the athletic programs of our school district. Students found to be in violation of this portion of the Athletic Code will be subject to disciplinary action through the athletic program, the school district, and the judicial system.

Examples of Hazing behavior/activities to avoid:

- Attending a skit night or roast where other members are humiliated
- Singing or chanting by you or with a few select team members in a public situation that is not related to the event, game or practice.
- Wearing clothing that is embarrassing or not part of the uniform
- Being yelled, screamed, or cursed at by other team/organization members
- Getting a tattoo or piercing of a body part
- Acting as a personal servant to other members
- Deprivation of sleep by other members
- Being awakened at night by other members
- Making prank phone calls or harass others
- Being tied up, taped or confined to small spaces
- Being transported to and dropped off in an unfamiliar location
- Enduring harsh weather without proper clothing
- Drinking large amounts of non-alcoholic beverage such as water
- Drinking large amounts of alcohol to the point of passing out or getting sick
